#### Amendment to Master Services Agreement

This Amendment to the Master Services Agreement ("Amendment") is made and entered into effective as of May 18, 2022 ("Amendment Effective Date") by and between WESTERN CLIMATE INITIATIVE, INC. a non-profit public benefit corporation ("WCI, Inc."), and Variance Infotech Private Limited (Contractor"). Capitalized terms used and not otherwise defined herein shall have their respective meanings set forth in the Agreement (as defined below).

#### Recitals

- A. On March 18, 2020, WCI, Inc. and Contractor entered into that certain Master Services Agreement ("Agreement") (formerly Contract No. 2020-02).
- B. WCI, Inc. and Contractor now desire to amend the Agreement to include Attachment A, Scope of Work and Work Authorization for Contractor to provide the requested software development services related to the Market Registry Project – Registration Module SOW and to make other conforming changes.

In consideration of the promises and the mutual covenants and agreements set forth below, the parties hereto agree as follows:

#### Agreement

- Attachment A (Scope of Work and Work Authorization). WCI, Inc. and Contractor agree to insert <u>Attachment A: Scope of Work and Work Authorization</u> and all of the documents and exhibits attached thereto (attached to this Amendment as <u>Exhibit A</u>) into the Agreement in their entirety. The duration of the Work Authorization is from May 18, 2022 through December 31, 2022.
- Amendment to Attachment B (Invoicing and Payment Terms). WCI, Inc. and Contractor agree
  that Attachment B shall be amended to add <u>Section C, Market Registry Project</u> Registration
  Module SOW <u>Budget Detail</u> (attached to this Amendment as <u>Exhibit B</u>) into the Agreement.
- 3. Attachments F and G (Contractor's Technical Proposal and Cost Proposal for the SOW/Work Authorization). WCI, Inc. and Contractor agree to insert <u>Attachment F: Contractor's Technical Proposal and Cost Proposal for the Market Registry Project</u> Registration Module SOW (attached to this Amendment as <u>Exhibit C</u>) into the Agreement in its entirety. All references to Attachment F are hereby amended to refer collectively to Contractor's Technical Proposal and Cost Proposal, and all references to Attachment G are hereby deleted from the Agreement.
- 4. Project Timeline and Key Personnel. WCI, Inc. and Contractor agree to update and finalize the Project Timeline and list of Key Personnel after the Kick-off Meeting. Once finalized, the Project Timeline and list of Key Personnel will be added to the Agreement by amending the Agreement.
- 5. Counterparts. This Amendment may be executed in several counterparts, each of which so executed shall constitute one and the same instrument. A signed copy of this Amendment delivered electronically shall be deemed to have the same legal effect as delivery of an original signed copy of this Amendment.
- Terms and Conditions. Other than as set forth above, WCI, Inc. and Contractor hereby confirm the terms and conditions of the Agreement shall remain unchanged, and the Agreement shall remain in full force and effect.




