1. Managing WCI, Inc. Committee Meetings

General discussion with Cliff Case providing update on legal counsel for managing committee meetings, and procedures for quorum and approvals.

3. Update on Application to U.S. IRS for Non-Profit Status

Patrick Cummins advised that external counsel is preparing a draft for the Committee to review by the end of this week.

Once the application is approved and filed, review/approval by the IRS will take between 2-6 months. The corporation's ability to conduct business will not be limited during this waiting period.

WCI, Inc. will not need to undertake a parallel process to register at the federal and provincial levels in Canada until WCI, Inc. opens a Canadian office.

Patrick will report back when the draft application is ready for the Committee's review.

4. Obtain an Employer Identification Number (EIN) from IRS

General discussion around requirements for obtaining an EIN; designating a responsible party, and obtaining

a mailing address in order to be able to apply for tax exempt status or open a bank account.

The Committee requested Patrick work with Directors to establish a responsible party and post

5. Other Next Steps to Get Started

Patrick Cummins provided an update on progress underway to register WCI, Inc. to do business. The Finance Committee met on November 22 and is working to complete the requirements to register the

corporation in California, and to identify the requirements needed to register in the Canadian provinces.

Completing these filings is their first priority and they will meet on a biweekly basis going forward. The

Finance Committee will provide regular updates for future Executive Committee meetings.
