

CONTRACT AMENDMENT: 2012-01-009

By this Amendment 2012-001-009, the Agreement number 2012-01 between SRA International Inc. (SRA or Contractor) and Western Climate Initiative, Inc. (WCI, Inc.), which was executed by the parties on May 8, 2012, and amended on December 20, 2012 (Amendment 2012-01-001), on December 9, 2013 (Amendment 2012-01-002), on March 5, 2015 (Amendment 2012-01-003), on August 4, 2015 (Amendment 2012-01-004), on January 1, 2016 (Amendment 2012-01-005), on October 12, 2017 (Amendment 2012-01-006), on November 14, 2018 (Amendment 2012-01-007), and on January 30, 2020 (Amendment 2012-01-008) (collectively, the Agreement) is hereby further amended as follows:

PURPOSE OF THIS AMENDMENT

1. Amend the Agreement to replace the Contractor as SRA has merged in General Dynamics Information Technology Inc. (GDIT). GDIT accepts and assumes all obligations of SRA and shall be the Contractor. GDIT will provide tracking system services for application development and support through 2024 for the Compliance Instrument Tracking System Service (CITSS) pursuant to the Agreement.

SPECIFIC TERMS AND CONDITIONS WHICH CONSTITUTE THE AMENDMENT

2. GDIT hereby assumes and agrees to perform and comply with all of the obligations and covenants of SRA under the Agreement, as amended, to be performed after the date of this Amendment 2012-001-009.
3. GDIT represents and warrants that has full right, power, and authority to execute and deliver this Amendment 2012-001-009, and that the Agreement, as amended, is a valid and binding obligation of GDIT.

EXPLANATION OF CHANGES

4. GDIT will provide CITSS application development and support for the Term as requested by the Participating Jurisdictions and as further set forth in the Agreement, as amended, including, but not limited to:
 - Operations and maintenance of the hosting, testing, and development environments including but not limited to system and application security and software updates.
 - Directed development from the jurisdictions, such as changes related to regulatory updates, modifications to improve user experience, or other improvements to support entity or jurisdiction business processes.
5. The amount of development and support work requested by Participating Jurisdictions of Contractor under the Agreement will be dependent on the needs of the Participating Jurisdictions as determined in their sole discretion and based on numerous variables including, but not limited to, an on-going road mapping exercise being conducted by WCI, Inc. and the Participating Jurisdiction. The “Current Agreement Not-to-Exceed Amount” above is **not** an estimate of expected service level in 2020, 2021, 2022, 2023 and 2024.

APPROVALS

This document and any attachments described herein constitute an amendment to the above numbered Agreement, as amended. All provisions of that Agreement, as amended, except those which are explicitly changed by this Amendment, shall remain in full force and effect.
