

CONTRACT AMENDMENT: MASTER SERVICES AGREEMENT Work Authorization (RFP#2020-08-01) (Sapient Corporation d/b/a Publicis Sapient)

Master Services Agreement Work Authorization RFP#2020-08-01 between Sapient Corporation d/b/a Publicis Sapient (“Contractor”) and Western Climate Initiative, Inc. (“WCI, Inc.”), which was executed by the parties on May 20, 2020, and amended on February 24, 2023, March 30, 2023, August 16, 2023, September 6, 2023, October 4, 2023, October 11, 2023, November 3, 2023, November 28, 2023, January 12, 2024, February 13, 2024, March 13, 2024, April 4, 2024, May 3, 2024, May 6, 2024, May 22, 2024, June 26, 2024, December 20, 2024, and August 1, 2025, is hereby further amended as follows:

Purpose of this Amendment

The parties agree to amend the Agreement to extend the available budget through December 31, 2026 for this **Time and Materials** Engagement and incorporate the following documents (and any documents or exhibits attached thereto) set forth below. This Amendment is effective as of the Effective Date for Amendment set forth above and Amendment No. 18 and the Statement of Work attached thereto dated August 1, 2025 (the “Amendment 18”) is deemed complete. For the avoidance of doubt, all Services performed and Deliverables provided between August 1, 2025 and the Effective Date for Amendment,

shall be deemed to have been performed pursuant to Amendment 18. The additional funding and any revised terms set forth herein shall apply only to Services performed on or after Effective Date for Amendment.

All capitalized terms not defined herein are given the meanings set forth in the Agreement. The Time and Materials Engagement Services are governed by this Amendment, and all other applicable provisions of the Agreement, as amended.
